Summary	Create Press Bulletin
Description	This use case allows Staff to order contests and add Board of Supervisors to create the Final Official Press Bulletin for an election. The press bulletin report displays election results by contest, summarized across the jurisdiction. There are three versions of the press bulletins: 1. Random Alpha, 2. Semi-Official and 3. Final Official. The candidate names on the random alpha press bulletin are sorted based on the Election's random alpha draw. This random alpha press bulletin is used internally for proofreading test results and etc. The candidate names on both the Semi-Official and Final press bulletins are sorted using the regular A-Z alphabet. The only differences between the semi and the final is that the final has the "Final Official" as part of the title and it also displays the names of the Los Angeles County's Board of Supervisors. Before the press bulletins are generated, the name of the Board of Supervisors must be inputted.
