FINALIZING TOUCHSCREEN EARLY VOTING LOCATIONS -2003 STATEWIDE SPECIAL ELECTION

The statewide recall election is scheduled for Tuesday, October 7th. Given that high voter turnout is anticipated for this election, the Los Angeles County Registrar-Recorder (RR/CC) recommends the operation of 12 Touchscreen Early Voting sites be available for eleven days. Touchscreen Early Voting will serve voters countywide, beginning on Wednesday, September 24th through Friday, October 3rd. As in the past when we have conducted early voting on touchscreen equipment, any registered voter may use the system at any of the available locations.

Site Selection Criteria

- □ **Consistency** History of site use by LA County/LA City and the numbers of voters the site served were the most critical factors when recommending sites.
- □ **Facility Credentials** Adequate size, disability access, ample free or fee waived parking and established T1communication lines.
- **Location** Proximity to freeways, major surface arteries and public transportation.
- □ **Host Partnerships** Established solid partnerships with our Touchscreen site hosts who are familiar with the system's requirements.

Timeline for Final Site Selections

Due to the time constraints of conducting this Statewide Special Election, we secured Touchscreen Early Voting sites that were both available during the early voting timeframe and that are familiar to voters from past Touchscreen Early Voting operations. Please refer to the attached site location chart as well as a countywide map denoting the locations. Selections must be finalized by August 6th in order to re-establish T1 communication lines and finalize the advertisement text for the sample ballot booklets.




