As of Thursday, July 12, 2018, the total election results that were certified on June 29, 2018 for the above precincts are 79,775 votes for Brad Sherman, 34,820 votes for Mark S. Reed, 6,727 votes for Raji Rab and 6,627 votes for Jon Pelzer. The total manual recount results for all of the above precincts recounted to date are 3,597 votes for Brad Sherman, 1,621 votes for Mark S. Reed, 286 votes for Raji Rab, and 273 votes for Jon Pelzer.
